The unrest on the other side, saw our province being reduced to ashes, and as a result a number of people in the province lost their jobs. That has exerted an immense pressure on us government to ensure that we rebuild our province and carter for all those who lost their sources of income.

While we were still in the process of recovery and rebuilding our economy, our Province was again hit by the devastating floods in March and April, which further destroyed our infrastructure. Last week we were briefed on the work that is currently being done by the commission with various public institutions within the province in improving on our conduct as public servants. We believe that this is very key as we are in the process of cleansing our government of any wrongdoing. Our ultimate goal is to run a clean and corruption free state.

As the provincial government, we commit to do our utmost best to ensure that we abide by the Public Service regulations, and to build and strengthen close relations with the Public Service Commission.

In conclusion, let me wish the commission well during your deliberations and again recommit in our support and working with the commission in ensuring that as government we continue to provide services to the people of KwaZulu-Natal.
