*This report uses data reported by municipalities by the 10th working day of the month, as required in Section 71(1) of the Municipal Finance Management Act, Act No. 56 of 2003 (MFMA). The report has been compiled based on information provided by the municipalities in the form of mSCOA data strings, Financial Management Reports (FMR) and other budget performance information for the financial period ended 30 September 2021 from the National Treasury's Local Government Database (NT LG Database). Therefore, any queries on the budget, revenue or expenditure figures reflected in the report must be referred to the relevant Municipal Manager or Chief Financial Officer. The quality of the report depends on the **reliability and credibility** of the information and figures submitted by the municipalities. It is noted that certain municipalities experience challenges with their financial systems as well as with the capturing of financial data in accordance with the mSCOA segments. These problems cause errors in the **submitted data strings** as well as inaccuracies in the financial information related to misalignment, cash flow and balance sheet budgeting.*

Methodology and Approach

The methodology and approach used for the compilation of this report included the following:

The data for the analysis used in this report was extracted from the NT LG Database as reported by municipalities for the financial quarter ended 30 September 2021. The non-delegated municipalities, namely, the eThekwi Metro, the Msunduzi and uMhlathuze Local Municipalities are included in the report. By the time of extracting the first quarter financial information from the NT LG Database on 18 October 2021, some municipalities may not have corrected the errors in their monthly MFMA Section 71 performance data strings. Such errors have may distorted the review of the budget performance as at the end of the first quarter for the respective municipalities, the district totals and the aggregated provincial total.

All municipalities should have generated and spent approximately 25 percent of their 2021/22 Approved Budgets as at the end of the first quarter.

1. Introduction

This consolidated municipal budget performance review covers the financial performance of municipalities in KZN as at the end of the first quarter of the 2021/22 financial year ended 30 September 2021.

The consolidated statement provides the in-year financial performance of municipalities against their budgeted revenue and expenditure. It includes the capital and operating budget performances as well as the debtors, creditors and conditional grants.

Assessing the expenditure performance of municipalities assists in serving as a control and management tool and serves as an early warning signal for identifying financial problems.

This is the third financial year that the report is prepared using the figures from the mSCOA data strings. The mSCOA Regulations were promulgated on 22 April 2014 and prescribed the uniform recording and classification of the municipal budget and financial information at a transaction level. The mSCOA Regulations require that municipalities upload their budget and financial information in a data string format to the Local Government portal across the six mSCOA regulated segments. The quarterly report has been prepared using the mSCOA data strings submitted by the municipalities, however the credibility of the information contained in the data strings is a concern. At the core of the challenge is:

- The incorrect use of the mSCOA segments and municipal accounting practices by municipalities;
- A large number of municipalities are not budgeting, transacting and reporting directly in/from their core financial systems. Instead they prepare their budgets and reports on excel spreadsheets and then import the excel spreadsheets into their financial system; and
- Municipalities are not locking their Approved Budgets annually on their financial systems. Furthermore, their financial systems are not being locked at month-end to ensure prudent financial management.

Legislative Framework

In terms of Section 71(7) of the MFMA, *the Provincial Treasury must, within 30 days after the end of each quarter, make public as may be prescribed, a consolidated statement in the prescribed format on the state of municipalities' budgets per municipality and per municipal entity. The MEC for Finance must submit such consolidated statement to the provincial legislature no later than 45 days after the end of each quarter.*

2. District Overview

2.1 Operating Revenue

- In aggregate, municipalities in KwaZulu-Natal generated *Operating revenue* amounting to R21.4 billion or 27.7 percent of the Original Budget of R77.3 billion. The revenue generated is above the expected straight-line projection of 25 percent at the end of the first quarter for the 2021/22 financial year.
- The eThekwin Metro with R11.5 billion or 53.6 percent contributed the most to the total *Operating revenue* of R21.4 billion followed by uMgungundlovu District with R2.3 billion or 10.8 percent. The high generation of revenue by the uMgungundlovu District was mainly attributed to the Msunduzi Local Municipality having reported R1.6 billion or 25.7 percent against the Original Budget of R6.4 billion during the first quarter.
- The King Cetshwayo District contributed R1.8 billion or 8.3 percent to the total *Operating revenue* of R21.4 billion, which can be attributed to uMhlathuze Local Municipality having reported R1.2 billion or 31 percent against the Original Budget of R3.8 billion. Msunduzi and uMhlathuze Local Municipalities are predominantly urban which results in higher *Operating revenue*.
- The uMkhanyakude District with R317.1 million or 1.5 percent contributed the least to the total *Operating revenue*. The low generation of revenue by the uMkhanyakude District was mainly attributed to the uMhlabuyalingana Local Municipality having reported only R7.1 million or 3.1 percent against the Original Budget of R228.2 million during the first quarter of the 2021/22 financial year. The municipality indicated that the amounts were incorrect and were in the process of making the necessary corrections.
- The *Service charges – electricity revenue* line item contributed the most towards *Operating revenue* as R6.3 billion or 29.3 percent was generated for the first quarter. *Other revenue* of R678.7 million or 3.2 percent contributed the least towards *Operating revenue* and it is made up of *Rental of facilities and equipment, Interest on external investments and outstanding debtors, Dividends received, Fines, penalties and forfeits, Licenses and permits, Agency services and Gains*.

- In aggregate, municipalities in KwaZulu-Natal incurred *Operating expenditure* amounting to R18.3 billion or 23.5 percent of the Original Budget of R77.9 billion. The expenditure incurred is below the expected straight-line projection of 25 percent at the end of the first quarter for the 2021/22 financial year.
- The eThekini Metro with R10.9 billion or 59.2 percent contributed the most to the total *Operating expenditure* of R18.3 billion followed by the uMgungundlovu District with R2.2 billion or 11.8 percent. The high expenditure rate reported by the uMgungundlovu District was mainly attributed to the Msunduzi Local Municipality having reported R1.7 billion or 27.7 percent against the Original Budget of R6.1 billion during the first quarter.
- The King Cetshwayo District contributed R1.4 billion or 7.7 percent to the total *Operating expenditure* of R18.3 billion, which can be attributed to uMhlathuze Local Municipality having reported R961.2 million or 24.6 percent against the Original Budget of R3.9 billion.
- The uMkhanyakude District with R253.8 million or 1.4 percent contributed the least to the total *Operating expenditure* of R18.3 billion. The spending rate reported by the uMkhanyakude District was mainly attributed to the district municipality having reported R53.3 million or only 9.9 percent against the Original Budget of R537.5 million during the first quarter.
- The *Bulk purchases* line item contributed the most towards total *Operating expenditure* as R5.8 billion or 31.8 percent was spent for the first quarter of the 2021/22 financial year. It is expected that *Bulk purchases* will contribute the most considering that revenue from Trading services, namely, *Service charges – electricity* also contributed significantly towards *Operating revenue*. *Remuneration of Councillors* of R185.8 million or 1 percent contributed the least towards *Operating expenditure*.

- Municipalities in KwaZulu-Natal generated *Capital revenue* amounting to R1.5 billion or 12.3 percent of the Original Budget of R12.1 billion at an aggregate level to fund their *Capital expenditure*. The revenue generated is significantly below the expected straight-line projection of 25 percent at the end of the first quarter for the 2021/22 financial year.
- The eThekuni Metro with R454 million or 30.6 percent contributed the most to the total *Capital revenue* of R1.5 billion but the least against their Original Budget when compared to the districts. The Zululand District was the second highest contributor with R170.8 million or 11.5 percent of the total *Capital revenue*.
- The Amajuba District with R46.2 million or 3.1 percent contributed the least to the total *Capital revenue* of R1.5 billion. The low generation of revenue by the Amajuba District was mainly attributed to the eMadlangeni Local Municipality having reported just R1 000 against the Original Budget of R19 million during the first quarter due to errors reported in the data string uploaded by the municipality.
- The highest contributor towards the total *Capital revenue* as at the end of the first quarter was *Transfers recognised – capital* at R1.2 billion or 79.6 percent followed by *Borrowing* at R158 million or 10.7 percent. The *Internally generated funds* with R144 million or 9.7 percent contributed the least towards the total *Capital revenue* during the first quarter.

- Municipalities in KwaZulu-Natal incurred *Capital expenditure* amounting to R1.5 billion or 12.8 percent in aggregate of the Original Budget of R12.1 billion. The expenditure incurred is below the expected straight-line projection of 25 percent at the end of the first quarter for the 2021/22 financial year.
- The eThekini Metro with R454 million or 29.3 percent contributed the most to the total *Capital expenditure* of R1.5 billion followed by the uMgungundlovu District with *Capital expenditure* of R192.6 million or 12.4 percent while the Amajuba District reported the least expenditure of R46.2 million or 3 percent. The low expenditure rate reported by the Amajuba District was mainly attributed to the eMadlangeni Local Municipality having reported just R1 000 against the Original Budget of R19 million during the first quarter due to errors reported in the data string uploaded by the municipality.
- The bulk of the total *Capital expenditure* as at the end of the first quarter was spent on *Water and waste water management* at R535.2 million or 34.6 percent with the Zululand District contributing the most in this category with R136.5 million or 25.5 percent. The second highest contributor toward *Capital expenditure* was *Road transport* with R506.8 million or 32.7 percent.
- The lowest contributor toward total *Capital expenditure* was *Health* with negative R37 000 that was reported by the eThekini Metro as at the end of the first quarter.
- The eThekini Metro reported negative *Capital expenditure* amounts of R22.5 million for *Water and waste water management* and R37 000 for *Health*. The municipality indicated that the negative amounts were due to the reversal of accruals for the previous financial year against the current year expenditure. Furthermore, the negative R2.5 million reflected by the King Cetshwayo District for *Governance and Administration* was due to the Nkandla Local Municipality reporting negative R5.7 million.

- The Total debt owed to municipalities at the end of the first quarter of the 2021/22 financial year was R34.6 billion which represents an increase of R3.4 billion or 11.1 percent from the R31.2 billion reported by municipalities in the fourth quarter of the 2020/21 financial year.
- At the end of the first quarter, a substantial amount of debt totalling R27.9 billion or 80.5 percent was outstanding in the *Over 90 Days* category, representing an increase of R2.3 billion or 9.1 percent from R25.6 billion reported in the same category for the fourth quarter of the 2020/21 financial year. In the first quarter, the Debtors per age category were as follows: *0-30 Days*: R3.5 billion or 10 percent, *31-60 Days*: R1.5 billion or 4.4 percent, and *61-90 Days*: R1.8 billion or 5.1 percent.
- Debt collection efforts must focus on these long outstanding debts however, some of these debtors may still need to be written off as they may have arisen as a result of the incorrect billing of indigent customers, amongst others. Municipalities are encouraged to update their Indigent registers to determine households that qualify for rebates and discounts with the aim of ensuring that debtors are accurately billed and reported.

- Amajuba District reflected negative R597.7 million for Debtors in the *0 to 30 Days* category which was as a result of the Newcastle Local Municipality reporting negative R606.3 million due to errors reported in the data string uploaded by the municipality.
- The Debtors Age Analysis by *Income source* shows that a significant amount of R11.8 billion or 34 percent of the debt owed relates to *Trade and Other Receivables from Exchange transactions - Water* followed by *Receivables from Non-exchange Transactions – Property Rates* at R9.5 billion or 27.5 percent.
- The Debtors Age Analysis by *Customer group* indicates that a considerable portion of debt is owed by *Households* at R23.5 billion or 67.8 percent followed *Commercial* at R7.2 billion or 20.9 percent.
- The continued increase in the level of debt owed to municipalities, is noted with concern as the municipalities should be implementing effective debt management and credit control measures in order to improve their debtors collection rates, which in turn will have a positive impact on their cash flows.

2.6 Creditors Age Analysis

- The total debt owed by municipalities at the end of the first quarter was R6.8 billion and it represents a decrease of R736.2 million or 9.7 percent from the R7.6 billion owed by municipalities as at the fourth quarter of the 2020/21 financial year.
- At the end of the first quarter of the 2021/22 financial year, a substantial amount of debt totalling R2.2 billion or 32.6 percent was outstanding in the *Over 90 Days* category, representing a decrease of R76.5 million or 3.3 percent from R2.3 billion reported in the same category for the fourth quarter of the 2020/21 financial year. It is concerning that 44 percent of the debt owed by municipalities, which amounts to R3 billion, was outstanding for longer than 30 days in contravention of Section 65(2)(e) of the MFMA.
- The Harry Gwala District reflected negative R1.7 million in the *30 to 60 Days* category which was as a result of the uBuhlebezwe Local Municipality reporting negative R2.2 million. The municipality indicated that accruals were raised for June at end of the previous financial year, however the payments were incorrectly recorded against the supplier instead of the accrual resulting in the negative amounts.
- The Zululand and uMkhanyakude Districts reflected negative R24.2 million and negative R11.7 million respectively in the *60 to 90 Days* category. The negative balance was as a result of the Nongoma Local Municipality reporting negative R26.1 million as well as the Big Five Hlabisa Local Municipality and the uMkhanyakude District Municipality reporting negative R1.3 million and negative R8.5 million in the Zululand and uMkhanyakude Districts respectively. The negative amounts are as a result of increased accruals being processed on the financial system as at the end of the previous financial year

while payment was subsequently made in July was misallocated.

- The iLembe District reflected negative R398 000 for the *Over 90 Days* category as a result of the district municipality reporting negative R1 million.
- The majority of the outstanding *Creditors* relate mainly to *Bulk electricity* of R2 billion or 29 percent followed by *Trade creditors* of R1.5 billion or 21.3 percent.
- Of the *Bulk electricity* outstanding creditors balance of R2 billion, R320.5 million was in the *Over 90 Days* category. This was mainly due to the fact that the Mpofana, and the Ulundi Local Municipalities reported amounts owing to Eskom of R260.2 million and R99.4 million for unpaid electricity respectively. Due to the poor collection of outstanding Debtors, the municipalities experienced cash flow challenges and were therefore unable to make full payment on invoices owed to Eskom. The Ulundi Local Municipality indicated that they are making payments according to the current repayment plan however they are in the process of negotiating a new payment plan with Eskom. The Mpofana Local Municipality indicated that they are currently still renegotiating a repayment plan with Eskom and the process has not yet been finalised, however they are currently making payments in line with the proposed repayment plan.
- Of the *Bulk water* outstanding creditors balance of R1.3 billion, R555.6 million was in the *Over 90 Days* category. This was mainly due to the fact that the Ugu District Municipality reported an amount owing to Umgeni Water Board of R273.8 million for unpaid bulk water. The municipality indicated that agreement has not yet been reached on a revised payment plan, however current amounts due have been paid to Umgeni Water Board. The uThukela District Municipality did not report the balance owed to Umgeni Water Board in their MFMA Section 71 data string however, the Umgeni Water Board indicated that the uThukela District Municipality owed the water board R205.8 million for unpaid *Bulk water* in their MFMA Section 41 report. The uThukela District Municipality indicated the negotiations for a repayment plan with Umgeni Water Board have not been finalised.

- Information relating to the direct allocations transferred to municipalities and the actual expenditure as per the National Departments as at the end of the first quarter was not available at the time of drawing the provincial report on 18 October 2021. The grant expenditure figures reported are based on the MFMA Section 71 monthly data string submissions made by the municipalities.
- In terms of the Division of Revenue Act, Act No. 4 of 2021 (DoRA), direct allocations to all 54 municipalities in KwaZulu-Natal, including eThekuni Metro amounted to R7.3 billion, while allocations in-kind amounted to R715.5 million, totalling R8 billion. Municipalities have reflected spending of R491.8 million or 6.7 percent against the total direct allocation of R7.3 billion.
- The total Municipal Infrastructure Grant (MIG) allocation to all the municipalities within the province was R3.4 billion, excluding allocations to the uMhlathuze and Ray Nkonyeni Local Municipalities as well as the eThekuni Metro. As at the first quarter, a total of R328.9 million or 9.6 percent was spent of the total MIG allocations to the applicable municipalities.
- The eThekuni Metro receives the Integrated City Development Grant (ICDG) and therefore does not receive the MIG allocation. The uMhlathuze and Ray Nkonyeni Local Municipalities receive the Integrated Urban Development Grant (IUDG) and therefore do not receive the MIG allocation.
- The total Integrated Urban Development Grant (IUDG) allocation to the Ray Nkonyeni and uMhlathuze Local municipalities was R210.9 million, of which R23.6 million or 11.2 percent was spent when compared to the allocations to municipalities as at the end of the first quarter of the 2021/22 financial year.
- According to the 2021 Division of Revenue Act 2021 (DoRA), the Integrated City Development Grant (ICDG) has been repurposed into the Programme and Project Preparation Support Grant (PPPSG). The eThekuni Municipality was allocated R49.9 million for this grant for the 2021/22 financial year but has not reported any spending against the allocation for the first quarter of the 2021/22 financial year.
- A total of 20 municipalities reported under-expenditure on their MIG allocations for the 2021/22 financial year. A further 17 municipalities reported no expenditure against their MIG allocations while three municipalities reported negative expenditure against their MIG allocations.
- The total Water Services Infrastructure Grant (WSIG) allocation to the municipalities within the province was R897.1 million. As at the first quarter, a total of R46.4 million or 5.2 percent was spent when compared to the allocations to municipalities. The following municipalities did not report any expenditure against their allocations and contributed to the under-spending of the WSIG namely: the Newcastle and uMhlathuze Local Municipalities together with the uMgungundlovu, uThukela, Amajuba, uMkhanyakude and Harry Gwala District Municipalities.

2.8 Non Compliance with the MFMA Reporting Requirements

KZN Provincial Treasury uses the monthly in-year reports, creditors, debtors and conditional grants reports to produce the MFMA Section 71(7) Consolidated Municipal Budgets Performance Report. At the time of extracting the Provincial Summary figures and Conditional Grants figures on 18 October 2021, it was noted that all 54 municipalities in KZN had submitted their Monthly IYM, Creditors and Debtors data strings for Months 01, 02 and 03 of the 2021/22 financial year.
